
We kept on exploring to find the best service mode for science and technology and financial chains, which integrated Angel Investment, Venture Investment, and Financing Guarantee.

As the core product of the Entrepreneurship Fund since its establishment, Angel Fund has been optimized 3 times in the last 8 years, in order to fulfill the requirements from the entrepreneurs. Up till today, over 2550 project applications have been received, among which 589 were successfully invested. Angel Fund has gradually become a seed, offering opportunities to entrepreneurs; a ruler, judging the talent in youngsters; a mirror, reflecting the value orientation of society. As the propellant and service providers for the young entrepreneurs, we feel deeply honored and proud and the growth of entrepreneurship motivates us to move forward.

Celebrating in the carnival of 'last day of 2012' with the entrepreneurs, 2013 marks a new begining for us. The Angel Fund will take further steps to be more oriented based on entrepreneurs' requirements. The process for application and investment should be optimized and the cycle time should be shortened, as well as enhancement of the post-investment management and services provided. We explored and organized the implementation of these platforms as well as the marketing model for project investment, management and service provisioning. 创业接力天使

Entrepreneurship Relay Angel

2012年,我们设立"天使投资专项引导基金",通过联合天使投资人服务早期企业。为天使投资人配套投入部分资金(单个项目最高50万元)以帮助投资人分担风险;在孵化服务方面,以创业接力大楼为载体,吸引与天使投资人共同投资的企业入驻,以集约化的方式帮助投资人降低投后管理成本。已与数十位天使投资个人和机构投资早期项目28个,投入资金1000万,引导社会资本约5000万。一年内已有2个项目退出,企业估值平均增长三倍;另外有2家企业获得了后续投资。

2013年,创业接力天使仍将继续与天使投资人联合支持早期项目,进一步筛选和支持合格的天使投资人,建立上海面向天使投资人的服务平台。

In 2012, the Entrepreneurship Fund set up a "Entrepreneurship Relay Angel", together with Angel Investors to provide services to early stage enterprises. Within the finance sector, we set up a "Special Guiding Fund for Angel Investment" to provide partial investment to angel investors (maximum RMB 500,000 for each project) to help investors share risks. Within the incubation service, we help enterprises invested together with angel investors reduce post-invest management cost in an efficient way. In one year since it's launch, we have invested in 28 projects at their early stages with about ten angel investors and institutions, the investment was around RMB 10 million and attracted RMB 50 million of social capital. 2 projects withdrew within the year and the average value assessment of enterprises increased 3 times; also, 2 enterprises got

Through our exploration and experience for more than a year, we strongly think that angel investment is worth encouraging and guiding and this is the right time for this In 2013, the Entrepreneur Relay Angel will continue to support the projects at their early stages jointly with angel investors, as well as further screening and support of qualified angel investors. We'll set up a service platform toward angel investors in Shanghai.



天使引导基金是创业基金会为推动天使投资发展而设立的鼓励个人或机构投资初创期、种子期企业的专项基金,由创业接力天使负责管理,面向所有天使投资人和天使投资机构开放。

Angel Dosing Fund is a special fund which was set up by the Entrepreneurship Fund in order to promote the development of Angel investment, and encourage individuals or institutions to invest in enterprises which are at their initialization and the growing stages. It is managed by the entrepreneurship relay angel and it is open to all angel investors and institutions.

天使引导基金的运作方式为配投,单个项目的投资额最高为50万元,共同投资的个人或机构在引导期(两年)内有权平价回购引导基金所持有的一半股权。

Operation method of Angel Dosing Fund is "follow on investment". The maximum investment of each project is RMB500,000. Co-investors, such as individuals or institutions have the right to purchase half of the equity held by the dosing fund at the original price during the guidance period (2 years).

2012年,天使引导基金投资项目为22个,投资额为962.5万,平均每个项目投资额为40万。其中,2个项目退出,2个项目获得后轮投资。

In 2012, Angel Dosing Fund had 22 projects, and the investment amount was RMB9,620,000 with an average investment of RMB400,000 per project. Among which, 2 projects withdrew and 2 obtained 2nd round investment.

In 2012, the third round of the Relay fund was set up, and the total amount collected was RMB230 million, over 50% of which was from private capital. 50.5 million in the first round and 50 million in the second round have already been invested.



Daokong Yu "Long term Development of Chinese future economy"

未来30年中国发展如何?最迅猛的30年是否已经过去?个人观点觉得中国未来仍保持20年的经济增长和繁荣没有太大的问题。

经济发展主要是由市场的供给、需求来决定的,现在普遍认为需求是重要的驱动力,但个人认为未来会以供给为更大的准绳。人的需求可以无穷大,而富有的地区总是供给更多、经济效率更高的地方,贫穷的地方则反之。所以中国目前的产能其实仍然不足,未能够满足相关的需求。

How will China develop in the next 30 years? Have the most rapid 30 years passed already? In my opinion, there is no problems for China to keep developing and flourishing its economy in the next 20 years.

Economic development is determined by market supply and demand. Now it is generally believed that demand is the important driving force, but I think that supply will be a greater principle in the future. People's demand can be expanded infinitely. In the rich areas there will always be more supplies and a more efficient economy, whilst it's on the contrary in poor areas. Therefore the current Chinese production capacity is still inadequate, and it doesn't fulfill the relevant demand.
